BCLA Merit Awards

Merit Awards are given to institutions in two categories. The first recognizes programs and services that are deemed to have significant benefit to the community served, and that also serve as exemplars to the entire BCLA community. The second category recognizes outstanding library building projects.

In Category A: Program and Services, five projects were nominated:

- BC Teacher Librarians' Association, Drop Everything and Read
- Coquitlam Public Library, Baby Storytimes at Seniors Centers
- Fraser Valley Regional Library, Aboriginal Outreach Services
- West Vancouver Public Library, Booktopia
- Irving K. Barber Learning Centre, UBC, BC Digitization Project.

And the winners are **Stephen Blaeser** and **Ryan Vernon** of the BC College and Institute Library Services (CILS), located at Langara College, a provincially funded library information services program for post-secondary students with print disabilities. In making their selection, the ALPS Award Committee noted Stephen and Ryan's innovative approach to supporting print-disabled clients. The committee was particularly impressed by these librarians' commitment to the principles of service, collaboration, teaching and training, and information

sharing across institutions and sectors, within and beyond the library community. Stephen and Ryan were both present to accept their awards.

Honorary Life Membership Award

The Honorary Life Membership Award is given to a BCLA member who is at or within five years of retirement. Individuals must have made substantial and recognizable long standing contributions to BCLA and to library service in the Province. And the winner this year is Mary Anne Epp, Director of Contract Services, Langara College. Mary Anne is also the Chair of the BCLA Copyright Committee. Mary Anne has spent her career acting as an advocate on issues related to copyright and access to information. She has provided copyright advice to college librarians and the provincial Ministry of Advanced Education. She has provided extensive support and worked diligently to promote Services to People with Print Disabilities. She has served as Chair of the Canadian Association of Educational Resource Centres for Alternate Format Materials and manages the Advanced Education media acquisitions program supporting the post-secondary system in BC. She is the manager of the College and Institute Library Services at Langara College. In her career, Mary Anne has contributed extensively to many publications, mentored colleagues, and presented numerous workshops She is a strong and eloquent spokesperson for college libraries and librarianship in Canada and an outstanding BCLA member.
