2010 Directions for the Information Policy Committee

In January, members of the BCLA Information Policy Committee gathered for a strategic planning meeting. Our priorities for this day were to:

- 1. Review the committee's terms of reference and the BCLA bylaws
- 2. Define the scope of our focus for the coming year, and
- 3. Plan some priority actions for the coming months.

At our planning meeting, founding members of the committee shared the history of the committee in order to contextualize our status quo. The IPC grew in the 1990's from a task force to a full committee of the BCLA board.

The IPC's role has traditionally been to advise the BCLA Board of Information Policy issues that need to be addressed, and provide support in doing so by

such activities as drafting letters and holding educational events.

Official committee members are active BCLA members who attend IPC meetings and/or otherwise carry out the work of the committee. However, our listserv includes many individuals who are not official committee members.

Following a SWOT analysis, the committee identified the following as priority issues for 2010:

- Freedom of Information and Protection of Privacy, including BC FIPPA
- Open Media, including the open Internet and media democracy/diversity
- Committee Communications, including our website, blog, and outreach activities

5 Facts About: FIPPA

- 1. FIPPA is the acronym for British Columbia's Freedom of Information and Protection of Privacy Act
- 2. FIPPA has 2 main purposes: governing Freedom of Information (FOI) requests for access to information held by public bodies, and determining how public bodies may collect, use and disclose personal information.
- 3. PIPA, the *Personal Information Protection Act*, is the corresponding law that governs how private organizations can collect, manage, use, and disclose personal information.
- 4. The B.C. Information and Privacy Commissioner is in charge of FIPPA and PIPA the current acting commissioner is Paul D.K. Fraser, Q.C.
- 5. FIPPA is subject to legislative review on a regular basis. The third legislative review is currently ongoing, and BCLA, via the Info Policy Committee, is a participant.
